

Upon receipt of Notice to Proceed, the CONTRACTOR must submit a
fabric sample same as the attached swatch to be provided by the
end user and a working drawing/product brochure with itemized
specification showing the motor track description, features,
installation etc. or an actual sample of the materials to be used at
least half a meter in length (if available) for approval within 7
(seven)P calendar days.

After the submitted specifications/actual sample has been approved, the CONTRACTOR may proceed to the installation of Motorized tracks, manual tracks, and curtains.

Installation must be done at a time and day when there is no events in the corresponding area for pull-out and delivery. It must be scheduled in the most convenient time in favor of PICC

- Upon inspection and acceptance by end-user representative, The CONTRACTOR may submit billing statement for finished works;
- 4. Final or last payment shall be subject to retention fee and shall be refunded by PICC after the final acceptance.
- 5. PICC shall have the right to deduct from the CONTRACTOR's billings such amount as may be necessary to cover the uncorrected discovered defects in the project.

#### III. Personnel

The Contractor's employees must at all times be in proper and clean uniforms. They must wear masks, PPEs and security ID issued by PICC. For purposes of identification, only one type of uniform and color scheme shall be adopted. The Contractor at its expense shall provide the uniforms.
