BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 042(07-21)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply and Delivery of Various Hardware Supplies, Parts and Materials consisting of six (6) lots, with a total Approved Budget for Contract (ABC) of **FOUR MILLION ONE HUNDRED SEVENTY-FIVE THOUSAND EIGHTY FOUR PESOS AND NINETY-THREE CENTAVOS (P4,175,084.93), VAT inclusive**;

WHEREAS, the sub-ABCs are as follows; Lot I: Carpentry Materials – ONE MILLION ONE HUNDRED FIFTY-FIVE THOUSAND THREE HUNDRED SEVENTY-ONE PESOS AND SEVENTY-FIVE CENTAVOS (P1,155,371.75); Lot II: Painting and Varnishing – ONE MILLION TWO HUNDRED FORTY-SEVEN THOUSAND ONE HUNDRED EIGHTY-TWO PESOS (P1,247,182.00); Lot III: Plumbing Materials – ONE MILLION FIVE HUNDRED TWENTY-SEVEN THOUSAND EIGHT HUNDRED SIX PESOS AAND SIXTY-EIGHT CENTAVOS (P1,527,806.68); Lot IV: Metal Works Materials – SIXTY-TWO THOUSAND THREE HUNDRED FORTY-FIVE PESOS (P62,345.00); Lot V: Masonry Materials – ONE HUNDRED TWENTY-FOUR THOUSAND NINE HUNDRED EIGHTY PESOS (P124,980.00) and Lot VI: Parts and Tools – FIFTY-SEVEN THOUSAND THREE HUNDRED NINETY-NINE PESOS AND FIFTY CENTAVOS (P57,399.50);

WHEREAS, in response to the said posting, five (5) suppliers, namely: ECS ROAD TRAFFICE SUPPLY ENTERPRISE ("ECS Road"), UP-TOWN INDUSTRIAL SALES, INC. ("Up-town"), PRIMEGOODS TRADING AND ELECTRICAL SUPPL CO. ("PRIMEGOODS"), VIVA SALES ENTERPRISES ("VSE") AND ST. CHRIST INTERNATIONAL TRADING ("St. Christ") obtained/paid for the bid documents. During the public bidding on June 22, 2021, ECS Road did not submit bid documents. Up-Town, Primegoods, VSE and St. Christ were declared ELIGIBLE and their bid proposals were as follows:
