

AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:



PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its Deputy General Manager, ROBERTO A. GARCIA, hereinafter referred to as "PICCI".

ACMI OFFICE SYSTEMS PHILIPPINES, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 268A N. Domingo St., San Juan City and represented herein by its Chief Operating Officer, GERARD JOSEPH B. ALAVA, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply and Installation of Split-Type, Inverter-Type Packaged Air-conditioning Units at Heroes Room, PH/RH VIP & Dressing Room in the total amount of ONE MILLION SIX HUNDRED FORTY-THREE THOUSAND PESOS (P1,643,000.00), VAT inclusive;

WHEREAS, the PICCI Management, approved, the award of the contract for the said projects to the CONTRACTOR, which offered the lowest calculated and responsive bid;

NOW, THEREFORE, the PICCI and the CONTRACTOR enter into this Agreement under the following terms and conditions;

- 1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. The Bid Proposal submitted on June 23, 2021, including the Eligibility, Technical, and Post Qualification Documents;
 - b. Section VI Schedule of Requirements;
 - c. Section VII Technical Specifications;
 - d. Section III Bid Data Sheet;
 - e. Section IV General Conditions of Contract;
 - f. Section V Special Conditions of Contract (SCC);
 - g. Notice of Award; and
 - j. Performance Bond.
- 2. In consideration of the payments to be made by the PICCI to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PICCI to provide the services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;
- 3. The PICCI hereby covenants to pay the CONTRACTOR in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum

as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines, on the day and year first above written.
