BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 051(08-21)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply and Delivery of Various Mechanical Supplies, Parts and Materials consisting of seven (7) lots, with a total Approved Budget for Contract (ABC) of TWELVE MILLION FIVE HUNDRED SIXTY-ONE THOUSAND NINE HUNDRED NINETY-ONE PESOS AND FIFTY-FIVE CENTAVOS (P12,561,991.55), VAT inclusive;

WHEREAS, the sub-ABCs are as follows; Lot I: Equipment Control Components – THREE HUNDRED FORTY-SIX THOUSAND NINE HUNDRED FIFTY-NINE PESOS AND SIXTY CENTAVOS (\$\mathbb{P}346,959.60); Lot II: Airconditioning System Parts and Accessories – EIGHT MILLION FIVE HUNDRED TWO THOUSAND ONE HUNDRED THIRTY-FOUR PESOS AND FIVE CENTAVOS (\$\mathbb{P}8,502,134.05); Lot III: York Chillers Consumable Materials – TWO MILLION EIGHT HUNDRED FIFTY-FIVE THOUSAND SIX HUNDRED PESOS (\$\mathbb{P}2,855,600.00); Lot IV: Sewage Treatment Plant Consumables – THIRTY-NINE THOUSAND FIVE HUNDRED EIGHTY-FIVE PESOS (\$\mathbb{P}39,585.00); Lot V: Mitsubishi Elevator Parts – ONE HUNDRED TWENTY-TWO THOUSAND FOUR HUNDRED NINETY-TWO PESOS AND FIFTY CENTAVOS (\$\mathbb{P}122,492.50); Lot VI – Kitchen Equipment Materials – FOUR HUNDRED SEVENTY-TWO THOUSAND EIGHT HUNDRED FIFTY PESOS (\$\mathbb{P}472,850.00) and Lot VII: Materials for Various Mechanical Works – TWO HUNDRED TWENTY-TWO THOUSAND THREE HUNDRED SEVENTY PESOS AND FORTY CENTAVOS (\$\mathbb{P}222,370.40);
