and




## WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee, invited bids for the Two (2) – Year Contract for the Daily Operation and Preventive Maintenance Service of PICC's Centralized Air-conditioning System (the "Project"), and has accepted a bid from the CONTRACTOR in the sum of Three Million Five Hundred Sixty-Four Thousand Pesos (\$\mathbb{P}3,564,000.00)\$, VAT inclusive; and

**NOW, THEREFORE**, PICCI and the CONTRACTOR hereby enter into this Agreement under the following terms and conditions;

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Special Conditions of Contract and in the Technical Specification of the bid documents;
- 2. The following documents shall be deemed to form, and be read and construed as, part of this Agreement, viz:
  - a. The Bid Proposal submitted on July 28, 2021, Eligibility Documents, Technical and Financial Components of the Bid;
  - b. Section VI Schedule of Requirements;
  - c. Section VII Technical Specifications;
  - d. Section III Bid Data Sheet;
  - e. Section IV General Conditions of Contract;
  - f. Section V Special Conditions of Contract (SCC);
  - g. Notice of Award; and
  - h. Performance Bond.
- 3. In consideration of the payments to be made by PICCI to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PICCI to undertake the completion of the Project in accordance with the Scope of Works enumerated in Section VII Technical Requirements of the bid documents, and to remedy defects therein in conformity in all respects with the provisions of the Contract;





4. The PICCI hereby covenants to pay the CONTRACTOR in consideration of the completion of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed in the SCC.
