GARCIA, hereinafter referred to as "PICCI".

and -

CAVAT CAPITOL MERCHANDISING AND CONSTRUCTION, a single proprietorship duly organized and existing under the laws of the Republic of the Philippines with office address at Maharlika Highway, Barangay Bayo, Iguig Cagayan 3504 and represented herein by its Special Project Manager, MARIO T. MACADAEG, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".


WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply of Labor and Materials for the Construction of Two (2) Emergency Exits at the Reception Hall ("the Project") and has accepted bid from the CONTRACTOR in the total amount of NINE MILLION FIVE HUNDRED EIGHTY-TWO THOUSAND SIX HUNDRED FORTY-SEVEN PESOS AND SIXTY-ONE CENTAVOS (\$\mathbb{P}9,582,647.61), VAT inclusive;

WHEREAS, the PICCI Management approved, the award of the contract for the said project to the CONTRACTOR, which offered the lowest calculated and responsive bid;

NOW, THEREFORE, the PICCI and the CONTRACTOR enter into this Agreement under the following terms and conditions;

- 1. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. The Bid Proposal submitted on April 12, 2019, Eligibility Documents, Technical and Financial Components of the Bid;
 - b. Section VI Specifications;
 - c. Section VII Drawings;
 - d. Section III Bid Data Sheet;
 - e. Section IV General Conditions of Contract;
 - f. Section V Special Conditions of Contract (SCC);
 - g. Notice of Award
 - h. Construction Schedule and S-curve;
 - i. Construction Method;
 - j. Construction Safety and Health Program; and
 - k. PERT/CPM; and
 - 1. Performance Bond.
- 2. In consideration of the payments to be made by the PICCI to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PICCI to provide the services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;





3. The PICCI hereby covenants to pay the CONTRACTOR in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
