INVITATION TO BID

ANNUAL SUBSCRIPTION OF FIREWALLS FOR SOPHOS SG310 & SG450 SERIES AND MAINTENANCE SUPPORT

The Philippine International Convention Center (PICC), through its Approved Budget for CY 2019, intends to apply the sum of **FIVE HUNDRED NINETY THOUSAND PESOS** (**P590,000.00**), being the Approved Budget for the Contract (ABC) of the aforesaid requirement.

The PICC now invites bids for the procurement of the abovementioned requirement. Contract duration is one (1) year. Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids, a contract similar to the project, whose value must be at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II – Instruction to Bidders. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding will be conducted through open competitive bidding procedures, using a non-discretionary "Pass/Fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, subject to the conditions for eligibility as provided in the RIRR of RA 9184. Interested bidders may obtain further information from the PICC-BAC and inspect the Bidding Documents at the address given below during office hours.

A complete set of Bidding Documents may be acquired by interested Bidders from March 6, 2019 to 11:00 a.m. of April 3, 2019, at the address stated below and upon payment in cash of a non-refundable fee, pursuant to the latest guidelines issued by the GPPB, in the amount of EIGHT HUNDRED PESOS (P800.00). It may also be downloaded, free of charge, from the website of the Philippine Government Electronic Procurement System (Phil-GEPS) and PICC website, https://www.picc.gov.ph, provided that participating Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

The PICC-BAC will hold a Pre-Bid Conference on **March 22, 2019 at 11:00 a.m.**, at the PICC-BAC Conference Room, Ground Floor, Delegation Building, which, however, shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat, at the address below, on or before **April 3, 2019 of 11:00 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Bid opening shall be conducted on **April 3, 2019 at 11:00 a.m.** at the PICC-BAC Conference Room, Ground Floor, Delegation Building, PICC. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.

In case the Pre-Bid Conference, the deadline for the submission of Bid Documents and the opening of bids fall on a non-working day, legal holiday or special non-working holiday, the activity involved shall be moved to 2:00 p.m. of the next working day.

The PICC-BAC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to its award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
