INVITATION TO RE-BID

SUPPLY AND DELIVERY OF VARIOUS MECHANICAL SUPPLIES, PARTS AND MATERIALS

The Philippine International Convention Center (PICC), through its Approved Budget for CY 2020, intends to apply the sum of **SIX MILLION NINE HUNDRED FORTY-EIGHT THOUSAND SIX HUNDRED EIGHTY-EIGHT PESOS AND SIXTY CENTAVOS (P6,948,688.60)**, being the total Approved Budget for the Contract (ABC) of the aforesaid requirement consisting of four (4) lots. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The PICC now invites bids for the procurement of the abovementioned requirement. Delivery shall be within ninety (90) calendar days. Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids, a contract similar to the requirement, whose value must be at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II – Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures, using a non-discretionary "Pass/Fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, subject to the conditions for eligibility as provided in the RIRR of RA 9184. Interested bidders may obtain further information from the PICC-BAC and inspect the Bidding Documents at the address given below during office hours.

A complete set of Bid Documents may be acquired by interested Bidders from February 16, 2021 to 9:30 a.m. of March 8, 2021, at the address stated below, upon payment in cash of a non-refundable fee, pursuant to the latest guidelines issued by the GPPB, in the following amount:

Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be conducted on **March 8, 2021, at 10:00 a.m**. at the PICC BAC Conference Room, Ground Floor, Delegation Building, PICC. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.

In case the Pre-bid Conference, the deadline for the submission of Bid Documents and the opening of bids fall on a non-working day, legal holiday or special non-working holiday, the activity involved shall be moved to 3:00 p.m. of the next working day.

The PICC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
