Negotiation shall be made with the contractor who made the lowest offer; should the negotiation fail then the same shall be made with the second lowest offer.

Attached are the Technical Specifications and other conditions for the implementation of the abovementioned requirements. Partial bid is not allowed. The goods are grouped in a single lot.
