by its General Manager, DEREK A. RAMSAY, duly authorized for the

purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited bids for the One (1) - Year Contract for the Monthly Preventive Maintenance Service of X-Ray Machines and Walk-Through Metal Detectors (the "Project") and has accepted a bid from the CONTRACTOR in the sum of ONE MILLION FOUR HUNDRED NINETY-ONE THOUSAND PESOS (P1,491,000.00), VAT inclusive; and

- 3. In consideration of the payments to be made by PICCI to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PICCI to undertake the completion of the Project in accordance with the Scope of Works enumerated in Section VII
