TECHNICAL SPECIFICATIONS

I. PROJECT TITLE:

Three (3)-Year Contract of Subscription and Maintenance of Anti-Virus License for 140 Users

II. APPROVED BUDGET FOR CONTRACT (ABC):

Eighty Two Thousand Eight Hundred Pesos (₱ 82,800.00), per year, VAT Inclusive

Note: The ABC is for the first (1st) year only. The Contractor shall maintain a satisfactory level of performance throughout the term of the contract. Based on the assessment, the PICC may pre-terminate the contract for failure of the Contractor to perform its obligations based on the latest Guidelines on Termination of Contracts issued by the Government Procurement Policy Board.

III. SCOPE OF WORKS AND SPECIFICATIONS:

- 1. Physical installation of anti-virus to 120 workstations and 20 servers
 - a. 20 servers Windows 2019 Server Standard Edition
 - b. 120 workstations and laptops (Windows 10)
- 2. Anti-Virus security shall have the following features:
 - a. Advance cyber-security network
 - b. Make files immune to malicious encryption
 - c. One click security protection that ruins itself
 - d. Preserves device speed and performance
 - e. Ultra-fast scanning
 - f. Protection against spam
 - g. Security for online transactions
 - h. Blocks insidious malware from entering Windows systems at boot up
- 3. Registration of device.
- 4. Download and installation of the feature key.
- 5. Upgrade device firmware to latest release, if needed.
- 6. Configuration of the Management settings.
- 7. Configuration of workstations.

8. One (1) year phone, email and on-line support.

IV. SCHEDULE OF REQUIREMENT:

The contract shall be within **Three (3)-Years** and shall complete the installation and configuration of the anti-virus license for fifteen (15) calendar days after the receipt of Notice to Proceed.

V. TERMS OF PAYMENT:

Payment shall be made in full after delivery, installation and configuration of the anti-virus license subject to ten percent (10%) retention money and other applicable taxes. The retention money shall only be released after the lapse of the one (1) year warranty period or upon issuance of a special bank guarantee equivalent to at least ten percent (10%) of the total contract price.

VI. WARRANTY:

One (1) Year Warranty and Support

VII. SPECIAL CONDITIONS OF CONTRACT:

- 1. Contract price shall be fixed and shall not be adjusted during the two (2)-year contract implementation.
- 2. Within ten (10) calendar days from receipt of the Notice of Award, but in no case later than the signing of the contract by both parties, the successful bidder shall furnish the performance security in any of the following forms:
 - a. Cash or Cashier's check/Manager's check or Bank draft/guarantee issued by a Universal or Commercial Bank in the amount which is equivalent to five percent (5%) of the contract price.
 - b. Surety bond, callable upon demand, in the amount which is equivalent to thirty percent (30%) of the Contract Price issued by a surety or insurance company duly certified by the Office of the Insurance Commission as authorized to issue such security.
- 3. The Performance Bond shall be renewed for the second (2nd) and third (3rd) year of contract.

VIII. GENERAL CONDITIONS OF THE CONTRACT:

- 1. All prices quoted herein are valid, binding and effective for One Hundred Twenty (120) calendar days from date of quotation.
- The Awardee shall be responsible for the source(s) of his services/equipment shall make deliveries in accordance with schedule, quality and specifications.
 Failure by the AWARDEE to comply with the same shall be ground for cancellation of the award.
- 3. The Awardee shall pick up RS and NTP issued in his favor within three (3) days after receipt of notice to that effect. A telephone call, fax transmission or email

- shall constitute an official notice to the AWARDEE. Thereafter, if the RS remain unclaimed, the said RS shall be sent by messengerial service to the AWARDEE at the latter's expense. To avoid delay in the service of the requesting agency's requirement, all DEFAULTING AWARDEES shall be precluded from proposing or submitting a substitute sample.
- 4. Subject to the provisions of the preceding paragraph, where AWARDEE has accepted a NTP but fails to deliver the services within the time called for in the same order, he shall be extended a maximum of fifteen (15) calendar days under liquidated damages to make good his services. Thereafter if AWARDEE has not completed delivery of services within the extended period, the subject RS & NTP shall be cancelled and the award for the undelivered balance withdrawn from that AWARDEE. The PICC-BAC shall then purchase the required services from such other source(s) as it may determine, with the difference in price to be charged against the DEFAULTING AWARDEE. Refusal by the DEFAULTING AWARDEE to shoulder the price difference shall be ground for his disqualification from future bids of the same or all items, without prejudice to the imposition of other sanctions as prescribed under RA 9184 and its IRR-A.
- 5. All services by the contractor shall be subject to inspection and acceptance by the PICC.
- A penalty of one tenth (1/10) of one percent (1%) of the total value of services/works shall be deducted for each day of delay in the delivery of the services.
- 7. All transactions are subject to withholding of creditable Value Added Tax (VAT) per Revenue Regulation No. 10-93.
