RENATO B. PADILLA, hereinafter referred to as "PICCI".

OPTIMUM SECURITY SERVICES, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 119 K-7 Street. Barangay East Kamias, Quezon City and represented herein by its Corporate Secretary, MARIA FE A. MAGNATE, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for a Two (2) - Year Contract for Security Services, which gave the lowest calculated and responsive bid in the total amount of TWENTY MILLION SIX HUNDRED TWENTY-TWO THOUSAND ONE HUNDRED TWENTY-THREE PESOS AND SIXTY-SEVEN CENTAVOS (P20,622,123.67), per annum, VAT

NOW THEREFORE, the parties hereby agree and covenant as follows:

 - a. The Bid Proposal submitted on October 19, 2018, Eligibility Documents, Technical and Financial Components of the Bid;
 - b. Section VI Schedule of Requirements;
 - c. Section VII Technical Specifications;
 - d. Section III Bid Data Sheet;
 - e. Section IV General Conditions of Contract;
 - f. Section V Special Conditions of Contract (SCC);
 - g. Notice of Award; and
 - h. Performance Bond.
- In consideration of the payment to be made by PICCI to the CONTRACTOR, the latter hereby covenants with PICCI to deliver the services required under the Two (2) - Year Contract for Security Services, subject of the public bidding, in conformity with the provisions of the SCC; and



3. **PICCI** shall pay the **CONTRACTOR**, in consideration for services rendered under this Agreement, the amount in accordance with the manner of payment set forth in the SCC.
