PADILLA, hereinafter to as "PICCI".

and

JSA, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 1869 P. Domingo St., Makati City and represented herein by its President, JOSEPH D. SERVER, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

## WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for a Two (2) - Year Contract for Regular Landscaping and Grounds Maintenance Services at the Center and has accepted a bid from JSA, Inc. who gave the single calculated and responsive bid in the amount of NINE MILLION ONE HUNDRED THIRTY-THREE THOUSAND EIGHT HUNDRED TWENTY-FOUR PESOS (\$\mathbf{P}9,133,824.00)\$, per annum, VAT inclusive;

- 3. The PICCI shall pay the CONTRACTOR, in consideration for the services rendered and goods delivered under this Agreement, the amount in accordance with the manner of payment set forth in the SCC.
