## **BAC Resolution Declaring LCRB and Recommending Approval**

## **RESOLUTION NO. 011(05-22)**

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Supply and Delivery of Regular Housekeeping Supplies**, with a total Approved Budget for Contract (ABC) of **TWO MILLION NINE HUNDRED FIFTY-FIVE THOUSAND FOUR HUNDRED SIXTY-TWO PESOS AND SEVENTY CENTAVOS (P2,955,462.70)**, **VAT inclusive**, consisting of three (3) lots;

WHEREAS, in response to the said posting, three (3) suppliers, namely: ECO-HYGIENE INSTITUTIONAL SALES ("Eco-Hygiene"), PRIMESOLV TECHNOLOGIES CO. ("Primesolv") and CARE 1<sup>ST</sup> CORP. ("Care 1<sup>st</sup>"), obtained/paid for the bid documents. Eco-Hygiene was declared Ineligible for failure to sign the Omnibus Sworn Statement. Primesolv and Care 1<sup>st</sup> were declared Eligible and their bid proposals were as follows:

WHEREAS, Care 1<sup>st</sup> was adjudged as the Lowest Calculated and Responsive Bid for Lots I and II, but was post disqualified for failure to submit the post-qualification requirements;

WHEREAS, CARE 1<sup>st</sup> was declared to have submitted an invalid bid for Lot III for failure to state "Comply" in Section 7 – Technical Specification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents, as well as post-qualification documents submitted by the second lower-ranked bidder, Primesolv for Lot III, the same were found to be complying and responsive.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC General Manager the following:

- a) To recommend to the PICC General Manager the award to Primesolv of the Supply and Delivery of Various Housekeeping Supplies (Lot III), as the bidder with the Lower Calculated and Responsive Bid whose total offer of ₱2,017,846.00 is within the ABC.
- b) To declare a Failed Bid for Lots I and I, and schedule a RE-BID to for such requirement
