Valero St., Bel Air, Makati City and represented herein by its President, EMMANUEL L. HERMOSA, duly authorized for the purpose, hereinafter referred to as "CONSULTANT".

WITNESSETH: That -

WHEREAS, the CONSULTANT was declared the Higher-Rated Offeror of the two (2) ad agencies that participated in the Public Bidding for Advertising Consultancy Services of PICC, with an Approved Budget for Contract (ABC) of THREE MILLION THREE HUNDRED EIGHTY-TWO THOUSAND PESOS (P3,382,000.00), VAT inclusive; and

WHEREAS, in the terms and conditions of the consultancy contract, PICCI and the CONSULTANT have agreed that, in consideration for the CONSULTANT's bid price of THREE MILLION THREE HUNDRED EIGHTY-ONE THOUSAND EIGHT HUNDRED TWELVE PESOS (\$\alpha\$3,381,812.00), VAT Inclusive, the duration of the Consultancy Contract shall be one (1) year.

NOW, THEREFORE, PICCI and the CONSULTANT enter into this Agreement under the following terms and conditions;

In consideration for the price of THREE MILLION THREE HUNDRED EIGHTY-ONE THOUSAND EIGHT HUNDRED TWELVE PESOS (\$\mathbb{P}3,381,812.00), VAT Inclusive, to be paid by PICCI to the CONSULTANT, the CONSULTANT hereby covenants with PICCI to execute and complete the Consulting Services and deliverables for a period of one (1) year and remedy any defects therein in conformity with the provisions of this contract in all respects; and



3. PICCI hereby covenants to pay the CONSULTANT in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
