PADILLA, hereinafter referred to

as "PICCI".

and

WIRELESS LINK TECHNOLOGIES, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 544 Florentino Torres St., Sta. Cruz, Manila represented herein by its Corporate Secretary, ANGELO B. DALISAY, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That-


WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply, Delivery, Installation and Configuration of Additional Access Point with Fiber Optics CAT6 Cable and Accessories and has accepted a bid from the CONTRACTOR in the sum of SIX MILLION SIX HUNDRED SIXTY THOUSAND THREE HUNDRED TWENTY-SIX PESOS AND FIFTY-SIX CENTAVOS (\$\frac{1}{2}6,660,326.56), VAT Inclusive;

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Special Conditions of Contract and in the Technical Specification of the bid documents;
- The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. The Contractor's Bid submitted on December 7, 2022, including the Eligibility, Technical, and Post-Qualification Documents;
 - b. Section VI Schedule of Requirements
 - c. Section VII Technical Specifications;
 - d. Section III Bid Data Sheet;
 - e. Section IV General Conditions of Contract;
 - f. Section V Special Conditions of Contract;
 - g. the Performance Security; and
 - h. the Notification of Award.
- 3. In consideration of the payments to be made by the PICCI to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PICCI to undertake the completion of the project in accordance with the Scope of Works enumerated in Section VII Technical Requirements of the bid documents, and to remedy defects therein in conformity in all respects with the provisions of the Contract;





4. The PICCI hereby covenants to pay the CONTRACTOR in consideration of the completion of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract specifically Section V – Special Conditions of the Contract.
