ADDENDUM NO. 01

This Addendum is issued to amend/revise certain provisions of the Bid Documents for the above-captioned procurement. Said amendments are as follows:

I. Section I- Invitation to Bid has been changed to read as:

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **9:30 am at January 18, 2023**. Late bids shall not be accepted
- 9. Bid opening shall be on **January 18, 2023, 10:00 am** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

II. III- Bid Data Sheet has been changed to read as:

- ITB Clause 14.1
 - a. In the amount of not less than **P419,883.64** or cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit;
- ITB Clause 17.1
 - The date and time of bid opening is **January 18, 2022** at 10:00 a.m.
- ITB Clause 20.2
 - c. Company Profile with statements that they have an established office/shop equipment and personnel (with sketch of office location) and that they have highly skilled technical personnel on **janitorial** equipment.

III. Section V- Special Conditions of the Contract have been changed to read as:

- GCC Clause 2.2 (page 25)
 - The absence of janitors or supervisors which results in the presence of less than **sixty four (64)** workers at any given

time shall cause the corresponding deduction from the billing statement, based on worker's daily rate, as prescribed by the existing minimum wage requirements for every eight (8) hours work shift.

IV. Section VIII- Checklist of Technical and Financial Documents have been changed to read as:

- I. Technical Component Envelope
 - Legal Documents
 - (a.) Certified Photocopy of the VALID PhilGEPS Registration Certificate (Platinum Membership) (all pages); if any of the documents mentioned in Annex "A" is not current, the new document should be submitted, **except for Business or Mayor's Permit of which the expired permit may be submitted, together with the official receipt for the application for the new permit, provided that the new permit shall be among the conditions for award of the contract.**
- II. Annex "B"
 - Single Largest Completed Contract form has been amended, as follows:
 - Note: The Single Largest Completed Contract shall be completed within the last **three (3) years** from the date of submission and receipt of bids, that is similar to the contract to be bid, the amount of which shall be at least fifty percent(50%) of the ABC.
- III. Annex "E"
 - Name of the Project: **Two (2) Year Contract for the Regular Janitorial, Sanitation, Carpet/Fabric Upholstered Furniture Maintenance Services**

V. "Attachment 1" of the Bid Form has been amended, as follows:

- Wage Order No. NCR-21 should read as Wage Order No. **NCR-23.**
