KNOW ALL MEN BY THESE PRESENTS:

This Agreement, entered into this **19** day of **JAN** 2023, in the City of Pasay, Philippines, by and between:

PHILIPPINE INTERNATIONAL CONVENTION CENTER, INC., a body corporate created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Roxas Boulevard, Pasay City, represented herein by its General Manager, RENATO B. PADILLA, hereinafter referred to as "PICCI".

and

LSERV CORPORATION, a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 21st floor Petron Mega Plaza Bldg., Makati City and represented herein by its President, JOSEPH V. ANGELES, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited bids for the Supply of Manpower Services to Complement the Existing Workforce of the Building Services Division and has accepted a bid from the CONTRACTOR which gave the lower calculated and responsive bid in the total amount of FOUR MILLION NINE THOUSAND ONE HUNDRED NINETEEN PESOS AND FORTY-EIGHT CENTAVOS (\$\bar{P}4,009,119.48), VAT inclusive;

WHEREAS, the PICCI Management, has approved the award of the Supply of Manpower Services to Complement the Existing Workforce of the Building Services Division, which Contract duration or service delivery shall be for twelve (12) months or one (1) year from receipt of the Notice to Proceed or until the contract amount is utilized whichever comes first, subject to the conditions as embodied in Section V — Special Conditions of the Contract;

NOW THEREFORE, the parties hereby agree and covenant as follows:

- 1. The following documents shall be deemed to form part, and be read and construed as part, of this Agreement, viz:
 - a. The Contractor's Bid Proposal submitted on December 27, 2022, including the Eligibility, Technical, and Post Qualification Documents;
 - b. Section VI Schedule of Requirements;
 - c. Section VII Technical Specifications;
 - d. Section III Bid Data Sheet;
 - e. Section IV General Conditions of Contract;
 - f. Section V Special Conditions of Contract (SCC);
 - g. the Performance Security; and
 - h. the Notification of Award.



- 2. In conside on of the payments to be made by PI I to the CONTRACTOR, the latter hereby covenants with PICCI to deliver the services required under the supply of manpower services to complement the existing workforce of the Building Services Division subject of the public bidding in conformity with the provisions of the SCC; and
- 3. **PICCI** shall pay the **CONTRACTOR**, in consideration for services rendered under this Agreement, the amount in accordance with the manner of payment set forth in the SCC.
