## **BAC Resolution Declaring LCRB and Recommending Award**

## **RESOLUTION NO. 12(03-23)**

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Supply and Delivery of Various Hardware Supplies, Parts and Materials consisting of six (6) lots, with a total Approved Budget for Contract (ABC) of FOUR MILLION EIGHT HUNDRED SIXTY-SEVEN THOUSAND TWO HUNDRED FORTY-THREE PESOS AND THIRTY CENTAVOS (\$\frac{9}{4},867,243.30)\$, VAT inclusive;

WHEREAS, the sub-ABCs are as follows; Lot I: Carpentry and Masonry Materials - ONE MILLION THREE THOUSAND FIVE HUNDRED EIGHTY-EIGHT PESOS AND FIFTY CENTAVOS (\$\mathbf{P}1,003,588.50)\$; Lot II: Painting and Varnishing Materials - TWO HUNDRED ONE THOUSAND FIVE HUNDRED FOUR PESOS (\$\mathbf{P}201,504.00)\$; Lot III: Plumbing Materials - TWO MILLION EIGHT HUNDRED FIVE THOUSAND FOUR HUNDRED TWO PESOS AND FIFTY CENTAVOS (\$\mathbf{P}2,805,402.50)\$; Lot IV: Metal Works Materials - SEVEN HUNDRED FOURTEEN THOUSAND FIFTY PESOS AND EIGHTY CENTAVOS (\$\mathbf{P}714,050.80)\$; Lot V: Parts and Tools - EIGHTY-ONE THOUSAND SEVEN HUNDRED NINETY-SEVEN PESOS AND FIFTY CENTAVOS (\$\mathbf{P}81,797.50)\$; Lot VI: Power Tools - SIXTY THOUSAND NINE HUNDRED PESOS (\$\mathbf{P}60,900.00)\$;

WHEREAS, in response to the said posting, five (5) suppliers, namely: BUILTRADE CONSTRUCTION SUPPLY ("BCS"), VIVA SALES ENTERPRISES ("VSE"), MARELCO TRADING CORP. ("MTC"), PRIMEGOODS TRADING AND ELECTRICAL SUPPLY CO. ("Primegoods") and UP-TOWN INDUSTRIAL SALES, INC. ("Up-Town"), obtained/paid for the bid documents. BCS was declared Ineligible for failure to submit 2023 Mayor's Permit. Other bidders were declared Eligible and their bid proposals were as follows:
