BAC Resolution Declaring a Failed Bid

RESOLUTION NO. 19(04-23)

WHEREAS, the PICC-BAC advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the **Supply and Delivery of Various Computer Peripherals, Laptop and 32" Plasma TV (Re-bid)**, consisting of two (2) lots. with Approved Budget for the Contract (ABC) of **ONE MILLION SIX HUNDRED TEN THOUSAND FOUR HUNDRED FIFTY PESOS (P1,610,450.00)**, **VAT Inclusive**; and

WHEREAS, in response to the said posting, two (2) bidders, MACROLOGIC DIVERSIFIED TECHNOLOGIES, INC. ("MDTI") and AGILE TECHFRONTIER CORPORATION ("ATC"), obtained the bid documents and submitted applications for eligibility on March 14, 2023. ATC was declared Ineligible for Lot II as its Purchase Order as the Single Largest Completed Contract (SLCC), does not include among the works stated therein, the installation of digital signage. ATC was found Eligible for Lot I and MDTI for Lot I and Lot II. Their bid proposals were found to be substantially complying:

WHEREAS, ATC was adjudged as the Lowest Calculated and Responsive Bid for Lots I and II, but was post disqualified due to the following reasons:

For Lot I - Failure to submit Section V (Special Conditions of the Contract) of the bidding documents and the brochure of the laptop for ACER Aspire 5 A515-57-7749 was not in accordance with the specifications

For Lot II - The submitted SLCC is not similar in nature

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents, as well as post-qualification documents submitted by the second lower-ranked bidder, MDTI for Lots I and Lot II, but was post-disqualified due to the following reasons:

- For Lot I Purchase Order as the Single Largest Completed Contract (SLCC), does not include among the works stated therein, the installation of digital signage.
- For Lot II Failure to signed the bidding documents, Bid Data Sheets (Section III) and Special Conditions of the Contract (Section V) and the brochure of the laptop for ACER Aspire 5 A515-57-7749 was not in accordance with the specifications.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to declare a **FAILED BID** for the abovementioned requirement; and
