RAMSAY, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply, Installation and Commissioning of One (1) unit 640 x 640 Advance Multiview X-ray Machine and One (1) unit 1000 x 1000 Advance Multiview X-ray Machine and has accepted a bid from the CONTRACTOR which gave the lone calculated and responsive bid in the total amount of TEN MILLION NINETY-NINE THOUSAND NINE HUNDRED NINETY-TWO PESOS (\$\mathbb{P}10,099,992.00), VAT inclusive;

- 2. In consideration of the payments to be made by the **PICCI** to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the **PICCI** to provide the services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;
- 3. The **PICCI** hereby covenants to pay the **CONTRACTOR** in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
