PADILLA, hereinafter referred to as "PICCI".

WITNESSETH: That -

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply of Labor and Materials for the Re-waterproofing of the Bell-end Roofdeck of Forum 1 & 3 ("the Project") and has accepted bid from the CONTRACTOR in the total amount of ONE MILLION FOUR HUNDRED FORTY THOUSAND PESOS (P1,440,000.00), VAT inclusive;

WHEREAS, the PICCI Management has approved, the award of the contract for the said project to the CONTRACTOR, which offered the lowest calculated and responsive bid;

NOW, THEREFORE, the PICCI and the CONTRACTOR enter into this Agreement under the following terms and conditions;

 - g. Notice of Award
 - h. Project Schedule/ Work Program and S-curve;
 - i. Project Safety and Health Program signed by the Safety Officer;
 - j. PERT/CPM; and
 - I. Performance Bond.
- In consideration of the payments to be made by the PICCI to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PICCI to provide the services, and to remedy defects therein in conformity in all respects with the provisions of the Contract;
- 3. The PICCI hereby covenants to pay the CONTRACTOR in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
