If any of the documents mentioned in Annex "A" is not current, the new document should be submitted.

- Statement of all on-going government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;
- 3. Statement of the Single Largest Completed Contract (SLCC) similar to the contract to be bid, entered into within the last ten (10) years from the date of submission and opening of bids, and whose value is at least fifty percent (50%) of the ABC. Attach to such statement the following;

a.Certified photocopy of the SLCC; and b.Certificate of Acceptance or Official Receipt or Sales Invoice

# 4. Net Financial Contracting Capacity (NFCC):

Computation of NFCC must be at least equal to the ABC to be bid, calculated as follows;

NFCC = [(Current assets minus current liabilities) (15)] minus the value of all outstanding or uncompleted portions of the projects under ongoing contracts, including awarded contracts yet to be started, coinciding with the contract to be bid. or a committed Line of Credit from Universal or Commercial Bank, in lieu of its NFCC Computation. The committed Line of Credit must be at least equal to ten percent (10%) of the ABC to be bid.

### **B. TECHNICAL COMPONENT:**

- e. Certificate of Satisfactory Completion & Acceptance of previous PICC projects undertaken within the last three (3) years, if any.

Negotiation shall be made with the bidder who made the lowest offer; should the negotiation fail then the same shall be made with the second lowest offer.

Attached is the Terms of Reference and other requirements for the implementation of the abovementioned requirements.

PICC reserves the right to reject any offer or all quotations found to be disadvantageous to the government.

### For Lot II

Payment shall be made within two (2) weeks after complete delivery and acceptance of the items by Facilities and Property Division, Administrative Department and submission of the Sales Invoice. Five percent (5%) of the payment shall be retained to cover the warranty obligations.

## F. Warranty period

For Lot I - Three (3) years warranty after acceptance by the PICC authorized representative of the delivered item.

For Lot II - Three (3) years warranty after acceptance by the PICC authorized representative of the delivered items.

The obligation for the warranty shall be covered by either retention money in an amount equivalent to five percent (5%) of the total contract price, or a special bank guarantee & equivalent to five percent (5%) of the total contract price. (Note: GPPB RES NO. 30-2017).

The said amount shall be released after the lapse of the warranty period or after consumption thereof, provided, that the supplies delivered are free from patent and latent defects and all the conditions imposed under the contract have been fully met.
