The total Approved Budget for Contract (ABC) for this project is **SIX HUNDRED THIRTY THOUSAND EIGHT HUNDRED PESOS (P630,800.00), VAT Inclusive.** 

Please submit your proposal on or before **3:00 p.m.** of **September 12, 2023** at the BAC Secretariat, Ground floor, Delegation Building, PICC together with the following:

### A. ELIGIBILITY DOCUMENTS:

- Statement of all on-going government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;
- 3. Statement of the Single Largest Completed Contract (SLCC) similar to the contract to be bid, entered into within the last three (3) years from the date of submission and opening of bids, and whose value is at least fifty percent (50%) of the ABC. Attach to such statement the following;
  - a.Certified photocopy of the SLCC; and
  - b.Certificate of Acceptance or Official Receipt or Sales Invoice
- 4. Net Financial Contracting Capacity (NFCC):
