

KNOW ALL MEN BY THESE PRESENTS:

This Agreement, entered into this _____ da**MAY** 1 6 2024 ____ 2024, in the City of Pasay, Philippines, by and between:

PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, RENATO B. PADILLA, hereinafter referred to

as "PICCI".

and

XITRIX COMPUTER CORPORATION, a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 23 Detroit St.,cor. Don Egea St., Brgy. Pinagkaisahan, Cubao, Quezon City represented herein by its CEO/President, JOEL C. SIA, duly authorized for the purpose, hereinafter referred to as "SUPPLIER".

WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for the Supply and Delivery of Seventy-One (71) Units Central Processing Units (CPU) and has accepted a bid from the SUPPLIER in the sum of FOUR MILLION EIGHT HUNDRED NINETY-SIX THOUSAND SEVENTY-FOUR PESOS AND THIRTY-EIGHT CENTAVOS (P4,896,074.38), VAT Inclusive;

WHEREAS, the PICCI Management has approved the award of the contract for said project to the SUPPLIER, which offered the lowest calculated and responsive bid;

NOW, THEREFORE, the PICCI and the SUPPLIER enter into this Agreement under the following terms and conditions;

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Special Conditions of Contract and in the Technical Specification of the bid documents;
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. The Contractor's Bid submitted on March 27, 2024, including the Eligibility, Technical, and Post-Qualification Documents;
 - b. Section VI Schedule of Requirements
 - c. Section VII Technical Specifications;
 - d. Section III Bid Data Sheet;
 - e. Section IV General Conditions of Contract;
 - f. Section V Special Conditions of Contract;
 - g. Performance Security; and
 - h. Notification of Award.
- 3. In consideration of the payments to be made by the PICCI to the SUPPLIER as hereinafter mentioned, the SUPPLIER hereby covenants with the PICCI to undertake the completion of the project in accordance with the Scope of Works enumerated in Section VII Technical Requirements of the bid documents, and to remedy defects therein in conformity in all respects with the provisions of the Contract;



4. The PICCI hereby covenants to pay the SUPPLIER in consideration of the completion of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract specifically Section V – Special Conditions of the Contract.
