

 - g. Performance Security; and
 - h. Notification of Award.

In consideration of the payments to be made by **PICCI** to the **CONTRACTOR**, the latter hereby covenants with **PICCI** to deliver the services required under the supply of manpower services to complement the existing workforce of the Building Services Division subject of the public bidding in conformity with the provisions of the SCC; and
