BAC Resolution Declaring Second-Ranked Bidder as LCRB and Recommending Approval

WHEREAS, the PHILIPPINE INTERNATIONAL CONVENTION CENTER – BIDS AND AWARDS COMMITTEE (PICC-BAC) advertised, through posting in the Phil-GEPS, PICC Website and in the bulletin board of the BAC Secretariat, the Invitation to Bid for the Three (3) Year Support/Maintenance and Hosting Service of PICC Website, with an Approved Budget for the Contract (ABC) of ONE MILLION SIX HUNRED THIRTY-FIVE THOUSAND PESOS (Php1,635,000.00) VAT Inclusive;

WHEREAS, in response to the said posting, three (3) bidders obtained and paid for the bid documents, namely: PURPLEBUG, INC. ("Purplebug"), EXIST SOFTWARE LABS, INC. ("ESLI") and MYBUSYBEE, INC. ("Mybusybee"). All bidders were declared eligible during the public bidding on April 4, 2024, except for ESLI for failure to attach the Sales Invoice and Official Receipt of its Single Largest Completed Contract (SLCC).

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by the first-ranked bidder Mybusybee, but was post-disqualified as it failed to attach certificate of satisfactory completion & acceptance of previous PICC projects undertaken within the last five years, although there were prior contract/s with PICC;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial documents as well as the post-qualification documents submitted by the second-ranked bidder, Purplebug, the same were found in order and its bid was found to be responsive.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the PICC Management the award to Purplebug of the aforesaid requirements as the bidder with the Lower Calculated and Responsive Bid whose total offer of \$1,600,000.00 is within the ABC.
