PHILIPPINE INTERNATIONAL CONVENTION CENTER INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710 with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, RENATO B. PADILLA, hereinafter referred to as "PICCI".

and

STAGE CRAFT INTERNATIONAL, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at 888 E. de los Santos Avenue, Mandaluyong City, represented herein by its President, MR. FRANCISCO N. ZABALA, duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That-
