INC., a government corporation created and existing by authority of Presidential Decree No. 520 dated July 23, 1974, as amended by Presidential Decree No. 710, with principal office at the PICC Complex, 1307 Pasay City, represented herein by its General Manager, RENATO B. PADILLA, hereinafter referred to as "PICCI".

and

MASADA SECURITY AGENCY, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at Unit 201 LQU Bldg., 624 G Araneta Ave., Brgy. Tatalon, Quezon City and represented herein by its President/General Manager, LT. COL. JOSE M. SOMBILLO (RET), duly authorized for the purpose, hereinafter referred to as "CONTRACTOR".

WITNESSETH: That-

WHEREAS, PICCI, through its Bids and Awards Committee (BAC), invited Bids for THIRTY-ONE MONTH SECURITY SERVICES FOR THE MAIN COMPLEX AND FORUM, which gave the lowest calculated and responsive bid in the total amount of SIXTY-SIX MILLION THREE HUNDRED SEVENTY-SIX THOUSAND TWO HUNDRED SIXTY PESOS AND THIRTY-NINE CENTAVOS (\$\textit{P}66,376,260.39)\$, VAT inclusive, which is within the Approved Budget for Contract of SEVENTY-SEVEN MILLION NINE HUNDRED FIFTY THOUSAND FOUR HUNDRED SIX PESOS AND SIXTY-SEVEN CENTAVOS (\$\textit{P}77,950,406.67)\$;

WHEREAS, the PICCI Board of Directors, approved and confirmed, via referendum, the recommendation of the PICC-BAC to award the Thirty-One (31) Month Security Services for the Main Complex and Forum to the CONTRACTOR;

WHEREAS, the contract period shall be from June 1, 2024 to December 31, 2026.

NOW THEREFORE, the parties hereby agree and covenant as follows:

- 1. The following documents shall be deemed to form part, and be read and construed as part, of this Agreement, viz:
 - a. The Bid Proposal submitted on April 29, 2024, Eligibility, Technical and Post-Qualification Documents;
 - b. Section VI Schedule of Requirements;
 - c. Section VII Technical Specifications;
 - d. Section III Bid Data Sheet;
 - e. Section IV General Conditions of Contract;
 - f. Section V Special Conditions of Contract (SCC);
 - g. Notice of Award; and
 - h. Performance Bond.
 - 2. In consideration of the payment to be made by **PICCI** to the **CONTRACTOR**, the latter hereby covenants with **PICCI** to deliver the services required under the Thirty-One (31) Month Security Services for the Main Complex and Forum, subject of the public bidding, in conformity with the provisions of the SCC; and



3. **PICCI** shall pay the **CONTRACTOR**, in consideration for services rendered under this Agreement, the amount in accordance with the manner of payment set forth in the SCC.
