- The PHILIPINE INTERNATIONAL CONVENTION CENTER (PICC) intends to apply
  the sum of TWO MILLION SIX HUNDRED FIFTY THOUSAND PESOS
  (P2,650,000.00), VAT Inclusive, being the Approved Budget for the Contract (ABC) for
  payments under the contract for the Consulting Services for the Concept, Design and
  Content Development of the PICC 50<sup>th</sup> Anniversary Coffee Table Book (APP No. 2024MC-141). Bids received in excess of the ABC shall be automatically rejected at bid
  opening.
- 2. The PICC now calls for the submission of eligibility documents for the Consulting Services for the Concept, Design and Content Development of the PICC 50<sup>th</sup> Anniversary Coffee Table Book. The Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before *March 3, 2025, 9:30 am, at the BAC Secretariat, Ground, PICC Delegation Building, Philippine Internaitonal Convention Center, Pasay City.* Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
- 3. Prospective Bidders may obtain further information from the PICC-BAC and inspect the Bidding Documentd at the address given below during office hours (Monday to Friday, 7:00 am-5:00pm.
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 5. A two-stage bidding procedure as specified in the RIRR of R.A. 9184 would be employed for this particular requirement. Bids will be evaluated using the Quality-Cost Based Evaluation. The contract will be awarded to the Highest Rated and Responsive Bidder (HRRB) which was determined as such during post-qualification.
- 6. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. 9.1	The BAC shall only consider for short listing those prospective bidders whose submitted contracts, as stated in the eligibility documents, are similar in nature and complexity to the contract to be bid.
